CHANGE OF COMPANY NAME AND LOGO

The Board is pleased to announce that the English name of the Company has been changed from “Crosby Capital Limited” to “AID Partners Capital Holdings Limited” and the Chinese name of the Company “滙友資本控股有限公司” has been adopted for identification purpose only to replace “高誠資本有限公司”.

The logo of the Company has been changed to  with immediate effect to reflect the Change of Company Name (as defined below).

CHANGE OF STOCK SHORT NAME

The Shares will be traded on the Stock Exchange under the new stock short name of “AID PARTNERS” in English and “滙友資本” in Chinese with effect from 9:00 a.m. on 6 February 2015. The stock code of the Company remains as 8088.

EFFECT OF THE CHANGE OF COMPANY NAME

The Change of Company Name will not affect any rights of the Shareholders. All existing share certificates of the Company shall continue to be evidence of title to the Shares and valid for trading, settlement, registration and delivery purposes. There will not be any arrangement for exchange of the existing share certificates.

CHANGE OF COMPANY WEBSITE

To reflect the Change of Company Name, the official website of the Company will be changed to www.aid8088.com with effect from 6 February 2015. Reference is made to the announcement of AID Partners Capital Holdings Limited (formerly known as Crosby Capital Limited) (the “**Company**”) dated 26 October 2014 and the circular of the Company dated 28 November 2014 (the “**Circular**”) in relation to, among other things, the Proposed Change of Company Name. Capitalised terms used herein shall have the same meanings as those defined in the Circular unless otherwise stated.

CHANGE OF COMPANY NAME AND LOGO

Following the approval by the Shareholders of the Change of Company Name at the EGM on 22 December 2014, the Board is pleased to announce that the Certificate of Incorporation on Change of Name was issued by the Registry of Companies in the Cayman Islands on 6 January 2015 certifying that the name of the Company has changed from “Crosby Capital Limited” to “AID Partners Capital Holdings Limited” and the adoption of the Chinese name of the Company “滙友資本控股有限公司” to replace “高誠資本有限公司” for identification purpose only (the “**Change of Company Name**”). The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 27 January 2015 confirming the registration of the new name “AID Partners Capital Holdings Limited” of the Company in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

The logo of the Company has been changed to  with immediate effect to reflect the Change of Company Name.

CHANGE OF STOCK SHORT NAME

Following the Change of Company Name becoming effective, the Shares will be traded on the Stock Exchange under the new stock short name of “AID PARTNERS” in English and “滙友資本” in Chinese, instead of “CROSBY CAPITAL” in English and “高誠資本” in Chinese respectively, with effect from 9:00 a.m. on 6 February 2015. The stock code of the Company remains as 8088.

EFFECT OF THE CHANGE OF COMPANY NAME

The Change of Company Name will not affect any rights of the Shareholders or the Company’s daily business operation and/or its financial position. All existing share certificates in issue bearing the former company name of “Crosby Capital Limited” shall continue to be evidence of title to such securities and the existing share certificates will continue to be valid for trading, settlement, registration and delivery purposes. There will not be any arrangement for exchange of the existing share certificates for new share certificates bearing the new company name. New share certificates will be issued under the new name of the Company with effect from 6 February 2015.
