Remarks: As approved at Extraordinary General Meeting on 24 May 2004, the 292,500,000 Non-voting Convertible Deferred Shares were allotted at a price of HK\$0.024 per Deferred Share. Following the share consolidation as approved at Annual General Meeting on 25 April 2008, the 292,500,000 Non-voting Convertible Deferred Shares were consolidated by a factor of 10 into 29,250,000 Deferred Shares. The Deferred Shares carry conversion rights into Ordinary Shares on a 1 for 1 basis with no conversion price upon conversion.
