The board of directors (the “**Board**”) of AID Life Science Holdings Limited (the “**Company**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on a preliminary review of the unaudited financial information of the Company and its subsidiaries (collectively the “**Group**”), the Group is expected to record a significant decrease in loss for the six months ended 30 June 2019 (the “**Period**”) as compared to that for the six months ended 30 June 2018, which was mainly attributable to significant decrease in fair value loss recognised as a result of fair value change of financial assets at fair value through profit or loss during the Period.

As the Group is still in the course of finalizing its consolidated financial results for the Period, the information contained in this announcement is only based on the unaudited draft consolidated financial statements of the Group for the Period, which have not been audited by the auditor of the Company nor reviewed by the audit committee of the Board as at the date of this announcement and is subject to possible adjustments upon further review. Shareholders and potential investors are advised to read carefully the interim results announcement of the Group for the Period which is expected to be published by mid-August 2019.
