The board of directors (the “**Board**”) of AID Partners Technology Holdings Limited (the “**Company**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on a preliminary review of the unaudited financial information of the Company and its subsidiaries (collectively the “**Group**”), the Group is expected to record a profit for the nine months ended 30 September 2016 (the “**Period**”) as compared to a loss for the corresponding period last year. The Board considers that the aforesaid turnaround from loss to profit was principally attributable to the substantial gain on the disposal of HMV M&E Limited and its subsidiary during the Period.

As the Group is still in the course of finalizing its consolidated financial results for the Period, the information contained in this announcement is only based on the unaudited draft consolidated financial statements of the Group for the Period, which have not been audited by the auditors of the Company nor reviewed by the audit committee of the Board as at the date of this announcement and is subject to possible adjustments upon further review. Shareholders and potential investors are advised to read carefully the third quarterly results announcement of the Group for the Period which is expected to be published by mid-November 2016.
