The board of directors (the “**Board**”) of AID Life Science Holdings Limited (the “**Company**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on a preliminary review of the unaudited financial information of the Company and its subsidiaries (collectively the “**Group**”), the Group is expected to record a significant increase in loss for the year ended 31 December 2018 (the “**Year**”) as compared to that for the year ended 31 December 2017, which was mainly attributable to significant increase in unrealised fair value loss recognised as a result of fair value change of financial assets at fair value through profit or loss during the Year.

As the Group is still in the course of finalizing its consolidated financial results for the Year, the information contained in this announcement is only based on the unaudited draft consolidated financial statements of the Group for the Year, which have not been audited by the auditor of the Company nor reviewed by the audit committee of the Board as at the date of this announcement and is subject to possible adjustments upon further review. Shareholders and potential investors are advised to read carefully the annual results announcement of the Group for the Year which is expected to be published before 31 March 2019.
